To become a candidate:

2. **Local Presidents** - Once the local delegates/alternates have been elected, the local president must complete the bottom section of the **Notice of Intent/Certificate of Election Form - Attachment B/C** - and return it to the MEA Executive Director **by March 4, 2019.** A form must be completed for each delegate and each alternate.
