**Retirees may elect the NEA-Retired Life one-time payment of dues (\$300 for Professional or \$180 for ESP) to be paid separately from the MEA and MEA-Retired annual dues in the first year of membership. In subsequent years, only MEA and MEA-Retired dues will be billed or deducted from MainePERS.
